Terms and Conditions

The promoter

Our offers are administered by London Venue Group of 49 Southwark Street, London SE1 1RU (registered number 10996970) (the “Promoter”).

1. Eligibility

- 1.1. Unless otherwise stated, our offers are available to all residents in the UK aged 18 years or over, except:
 - (a) employees of the Promoter or its holding or subsidiary companies;
 - (b) employees of agents or suppliers of the Promoter or its holding or subsidiary companies, who are professionally connected with the offers or their administration;
 - (c) members of the immediate families or households of (a) and (b) above; or
 - (d) any third party directly associated with administration of the promotions.
- 1.2. In taking advantage of these offers, you confirm that you are eligible to do so and eligible to claim any discount you request. The Promoter may require you to provide proof that you are eligible to benefit from the offers.
- 1.3. The Promoter reserves all rights to refuse the discounts if your conduct is contrary to the spirit or intention of the promotion.

2. The offer: 50% discount on your 4th visit

- 2.1. The promoter is offering a discount of 50% on your bill on your 4th visit booking a table in the Courtyard under your name using a single email address.
- 2.2. A minimum spend of £10 will apply to each visit.
- 2.3. Only one discount may be applied per table.
- 2.4. Bookings at Sushi on Jones are excluded and your discount will not apply to any spend at Sushi on Jones.
- 2.5. All 4 visits must take place between 24 June 2021 and 31 October 2021 (inclusive).

3. The offer: 20% discount on drinks for local businesses

- 3.1. The promoter is offering employees at selected local businesses a discount of 20% off drinks purchased from the bar in the Courtyard where a table has been booked in advance.
- 3.2. This offer is available to employees whose businesses have received an email and who are able to show a valid company ID card.
- 3.3. Discount available between 24 June 2021 and 31 August 2021 (inclusive).

4. Limitation of liability

Insofar as is permitted by law, the Promoter, its agents, or distributors will not in any circumstances be responsible or liable to compensate the winner or accept any liability for any loss, damage, personal injury or death occurring as a result of taking up the discount except where it is caused by the negligence of the Promoter, its agents or distributors or that of their employees. Your statutory rights are not affected.

5. Data protection and publicity

- 5.2. By entering, you agree that any personal information provided by you with your entry may be held and used by the Promoter or its agents and suppliers to administer the offers. Your personal data will not be used for any other purpose, unless you have also consented to receive marketing communications from us.

8.1 If there is any reason to believe that there has been a breach of these terms and conditions, the Promoter may, at its sole discretion, reserve the right to exclude you from participating in the promotion. The Promoter reserves the right to refuse entry or refuse to award the offers to anyone in breach of these terms and conditions.

8.2 The Promoter reserves the right to hold void, suspend, cancel, or amend the offers where it becomes necessary to do so.

8.3 All offers and these terms and conditions shall be governed by English law, and the parties submit to the non-exclusive jurisdiction of the courts of England and Wales.
